

1. GENERAL INFORMATION

The following organizational changes are scheduled to take effect for **trade-date 4th February 2008**. Please update your records accordingly:

In order to concentrate market risks Erste Bank Group will conduct all trading operations on a central trading book for the following entities, effective trade-date 4th February 2008:

- Erste Bank der oesterreichischen Sparkassen AG Vienna,
- Česká spořitelna, Prague,
- Slovenská sporiteľňa, Bratislava,
- Erste Bank Hungary Budapest,
- Erste Befektetési Zrt Budapest

This organizational change will not lead to a centralization of personnel. Traders will still be located in these entities, acting as competence centers across the whole Erste Bank Group for certain products in close touch with local markets. Sales operations and all other business activities facing clients stay local as well.

Effective trade-date 4th February 2008 all market-making and trading business with these entities will henceforth be transacted in the name of

"ERSTE Bank der oesterreichischen Sparkassen AG, Vienna" (BIC: GIBAATWW)

2. LIMITS:

We further request that any limits allocated to electronic trading platforms, such as Reuters 3000 or EBS, to be reallocated under the name of ERSTE Bank der oesterreichischen Sparkassen AG, Vienna under the new dealing code.

For counterparties based in countries of one of our subsidiaries we kindly ask to set limits for Money Market business in local currency. The respective subsidiary will contact you directly with further details.

3. SETTLEMENT:

- Existing trades with affected entities maturing after the 4th of February 2008 will NOT be migrated to the new system and will be settled as originally confirmed!
